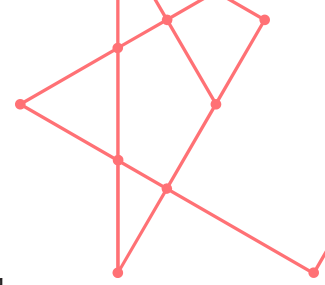

An angle which is often overlooked is what all of this means in practice **for the businesses in the real economy**, which are the ultimate recipients of the financial flows intermediated by the financial sector. If you are running an operational business (whatever the industry), you are probably wondering which aspects of this transition will have a big impact on you.

This year, the [annual conference](#) brings together leading names from the worlds of business, academia and politics to discuss and debate some critical issues linked more specifically with the environmental transition embedded in the push towards a more sustainable future.

The academics and experts will examine three key aspects in depth, all related



to the green transition: taxonomy (reporting), environmental Tax and the energy issue.

The first half-day will host keynote speeches addressing these three areas, and will see internationally renowned experts provide an up-to-date overview of the strategic issues in these three topics. The second half-day will allow you to ask questions, to deepen the topics in elective workshops and will give you the opportunity to listen to a panel debate on the specific impacts for Luxembourg companies, in particular on the energy issue.
