Patrick Klein has been Managing Director of Dyckerhoff GmbH in Wiesbaden since July 1, 2023.

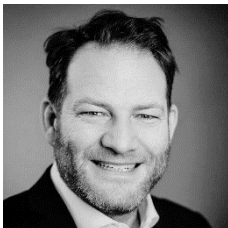

Stéphane holds a degree as sales engineer from the Esidéc business school in Metz (France).

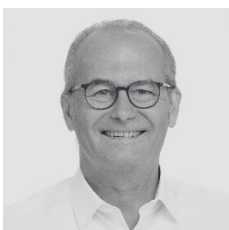


Dr Gaston Trauffer

After completing his secondary education, Claude Turmes graduated in physical and sport education from the University of Louvain-la-Neuve. In parallel with his teaching career, he furthered his knowledge of environmental technologies, engaging in studies at the Luxembourg University Foundation in Arlon.

Claude Turmes embarked on a dynamic political journey when he was first elected as a Member of the European Parliament in 1999, representing the Luxembourgish Green Party (déi gréng). He continued to secure re-elections in 2004, 2009, and 2014.

In June 2018, Claude Turmes was appointed Secretary of State for Sustainable Development and Infrastructures. After the legislative elections of October 2018, Claude Turmes was appointed Minister for Energy and Minister for Spatial Planning in the coalition government formed by the DP, the LSAP and déi gréng. He remained minister until the national legislative elections in October 2023.
